For legal entities (businesses, foundations etc):

- Legal person's certificate of registration (printed no more than two months ago)
- A verified and dated copy of the contact person's valid ID document (e.g. a valid driving licence, certified ID card or passport)
- A power of attorney, if the contact person is not an authorized signatory of the legal person.

If the required documents have not been received, the issuance of fund units may be delayed or denied.

A contract note will be issued when the purchase amount has been received and the value of the units determined.
